Community Foundation Grant - Summer Science Academy 2018

The Dickinson County Community Foundation awarded \$5000 in grant money to the 2018 Summer Science Academy.

Randy Gassman moved to accept the grant by the Dickinson County Community Foundation. Mark Wilson seconded the motion. Motion carried 5-0.

The board thanked the Community Foundation for supporting this program.

Whelan Kansas Leadership for Learning Award

Dr. Guy recognized and congratulated Chris Cooper for being selected as the 2018 Whelan Kansas Leadership for Learning Award winner. This award is through KU and recognizes individuals or groups for their extraordinary leadership and vigorous pursuit of opportunities to learn for each and every student.

Kansas Education Systems Accreditation (KESA)

Chris Cooper presented Abilene's KESA report for Year 4 to the board. He noted that Abilene was commended for their MTSS structure especially in reading.

Action/Discussion Items

2018-2019 Milk Bids

There was only one milk bid this year and that was from Hiland Dairy for \$55,421.25. Food Service Director, Caleb Angolo, recommended that the board approve this bid.

Kyle Becker moved to accept the milk bid from Hiland Dairy. Chris West seconded the motion. Motion carried 5-0.

Food Service 2018-2019 Meal Price Increase Proposal

The district is required to follow federal mandates in order to receive funding for the food program. In following with these mandates, food service director, Caleb Angolo, presented two options. Caleb recommended a \$.10 increase in student lunches and a \$.05 increase in student breakfasts. He also recommended that adult lunches remain at 3.60.

Randy Gassman moved to entertain option 1 for approval which increased student lunches by \$.10 and student breakfasts by \$.05. Mark Wilson seconded the motion. Motion carried 5-0.

Bus Request for Proposal (RFP)

The bus bid summary was presented to the board. Transportation Director, Heather Henkle, recommended a 2016 71-passenger bus from Midwest Bus for \$69,850. Discussion was held.

Kyle Becker moved to accept the bid from Midwest Bus Sales for \$69,850. Randy Gassman seconded the motion. Motion carried 5-0.

Building Trades House Offer

Dr. Guy received an offer for \$55,000 on the building trades house and recommended approval of the offer.

Chris West moved to accept the offer of \$55,000 for the building trades house. Kyle Becker seconded the motion. Motion carried 5-0.

2018-2019 District Insurance Premium

Dr. Guy informed the board that the district insurance renewal premium for 2018-19 is \$314,957. This is a savings of \$30,445 from last year's premium. Coverage is the same except the umbrella coverage was increased to 5 million. The savings is due to the workers comp coming in lower.

Mark Wilson moved to approve the insurance renewal premium for 2018-19. Randy Gassman seconded the motion. Motion carried 4-0-1 (Kyle Becker abstained).

Facilities/Technology

Crisis Plan and Safety

Dr. Guy updated the board on the Crisis Action Plan that has been implemented since members of the school and community went to Columbine for training. Police Chief Mike Mohn and Firefighter Jeremy Stuck spoke about the reunification training that has been started in the schools and the importance of discussion and the continuation of these exercises. On behalf of the district, Dr. Guy thanked the Fire Department, Police Department, EMS, and the Sheriff's department for their participation and also the Noel family for providing the funding for the Columbine training.

Policy

AHS Athletic Policy

This was the second reading of the Alcohol/Tobacco/Drug Policy for AHS Extracurriculars that was revised to make it more serviceable. Discussion was held.

Kyle Becker moved to accept the new Alcohol/Tobacco/Drug Policy for AHS Extracurriculars. Mark Wilson seconded the motion. Motion carried 5-0.

Consensus of the board was to move forward with community involvement in the discussion on random drug testing.

Student Development

2018-2019 Handbooks

Handbooks were presented for review to the board. Principal Delay highlighted the changes to the AMS handbook and noted that this is the first year for the AMS Athletic handbook. Dr. Smith submitted an early release proposal to be added to the AHS handbook.

This was the first reading for the board and will be reviewed again in July.

Graduation for the 2018-19 school year will be on Sunday, May 19th at 1:30 p.m.

2018-2019 District Health Insurance

Dr. Guy informed the board that the health and dental insurance premiums with Blue Cross Blue Shield of Kansas will be increasing by approximately 17%.

Close Out 2017-18 Fiscal Year

Last year, instead of scheduling a meeting to close out the end of the fiscal year, the board gave the superintendent and board clerk the authority to make the necessary end of year transfers to close out the fiscal year. Dr. Guy requested permission for that authority again this year.

Randy Gassman moved to allow the superintendent and board clerk the discretion to make the necessary end of year transfers. Kyle Becker seconded the motion. Motion carried 5-0.

On behalf of the board, Jeff Bathurst presented Dr. Guy with a gift and thanked her for her 22 years of service to the district.
