#### **Action/Discussion Items**

# Personnel Update

Denise summarized the Personnel Update (attached). A motion was made by Mark Wilson to approve the update as presented. Debby Barbur seconded and the motion carried unanimously. According to Denise there have been no applications for the vacated AHS industrial arts teacher position. Discussion ensued regarding how to address this situation.

#### Legislative Update

On May 27, 2016, the Kansas Supreme Court struck down the legislature's plan to remedy funding for poor school districts. Denise gave a brief summary of how we got to this point. The Kansas Supreme Court is holding to it's June 30, 2016 deadline to fix this problem. With the current legislative session scheduled to end tomorrow, a special session may needed. If the problem is not fixed by the deadline, the Kansas Supreme Court has threatened to shut schools down effective July 1, 2016.

If schools are shutdown, they will not be able to allocate funds, spend funds or raise taxes. Denise stated that this affects student's constitutional right to a suitable education. There are many questions and few answers to the issues that a shutdown would cause. Among the questions were: how strict will the court's order be, how would it affect 12 month employees, will the board extend the lump sum payment deadline, etc. According to Denise, the Kansas Association of School Boards (KASB) and the Kansas State Department of Education (KSDE) will provide guidance if a shutdown happens. However, they have no more answers than we do at this time. USD #435 is one of the largest employers in Abilene. How would a shutdown affect the city?

Denise has visited with Representative John Barker regarding this matter. John believes that Governor Brownback will call a special session towards the end of June and stated that there are legislators currently working on a remedy. Much discussion ensued.

The next topic of discussion was transgender restrooms. Kansas legislators are not supportive of the federal law regarding this subject. Denise stated that once construction is complete, the high school will have 4 gender-neutral restrooms.

#### Other

Board members asked Denise if the sports banner topic at the high school has a plan yet. According to Denise, the banners are down at the moment to allow painting of the performance gym and that high school administrators Ben Smith and Will Burton are working on a plan.

Denise informed board members that the building trades house sold at auction on May 21, 2016 at 10:00 a.m. for \$67,000.00 to Chrissy and Chad Fink. Debby Barbur moved with a second from Mark Wilson to approve the sale as reported. The motion carried unanimously.

The Community Foundation of Dickinson County awarded the Summer Science Academy with an \$8,000.00 grant. A motion was made by Mark Wilson to approve the grant. Debby Barbur seconded and the motion carried unanimously.
