#### Presentation/Donations

## Jeffcoat donations

Hank Royer, on behalf of the Jeffcoat Foundation, donated \$16,000 to USD 435 with \$10,000 going to the Summer Science Academy and \$6,000 going to the 3 elementary schools for the Positive Behavior Intervention System (PBIS).

Kyle Becker moved to accept the donation from the Jeffcoat Foundation. Jennifer Waite seconded the motion. Motion carried 7-0.

## Community Engagement

## Resource Officer Proposal

Dr. Guy and Police Chief Mohn worked together on a proposal to share a resource officer for 260 days with a 50/50 cost split with the City of Abilene. The city would bill the district quarterly. The resource officer would be Officer Kobiskie and his office would be in a room at the high school.

Chris West moved to accept the Resource Officer proposal. Randy Gassman seconded the motion. Motion carried 7-0

#### **Banking Services RFP**

Astra Bank, First Bank Kansas, and Pinnacle Bank had submitted banking services RFPs. Dr. Guy summarized the RFPs noting that Astra Bank had given the best interest rate. Discussion was held.

Randy Gassman moved that the district's banking services go to Astra Bank for the next school year. Kyle Becker seconded the motion. Motion carried 7-0. The Board thanked Pinnacle Bank for their services these 5 past years.

#### Abilene Cares Coalition

Dr. Guy informed the board that the Abilene Cares Coalition was working on or with the following groups or projects: Proverty Simulation, Mentor Program, Crime Stoppers anonymous reporting system for students, Friends for Life - Suicide Prevention Program, Neighbor to Neighbor - Neighborhood Express Transportation, Central Kansas Mental Health.

## **Student Development**

## 2018-2019 Instructional Resources

Chris Cooper presented the Instructional Resource Proposal for the 2018-19 school year. The main focus would be the K-12 Science. The total cost for this year would be \$77,993.58.

Randy Gassman moved to approve the Instructional Resource Proposal as presented. Jennifer Waite seconded the motion. Motion carried 7-0.

#### Band Enrollment Fee

A request was made to allow for the collection of a \$40 band fee at enrollment. This \$40 would cover the cost of the t-shirt that is required, gloves, replacement of drum heads/mallets for percussionists, State Fair entry, uniform fitting/tailoring, shoes, and awards. Discussion was held.

Gregg Noel moved to allow the collection of a \$40 band fee at enrollment. Kyle Becker seconded the motion. Motion carried 7-0.

#### PAT Budget 2018-19

Dr. Guy presented the 2018-19 PAT proposed budget to the board. The proposed budget showed an increase of \$2,786 from \$37,295 to \$40,081. With this budget, the district would increase the in-kind contribution. The budget increase would allow PAT to service more students. Discussion was held. The board will review the PAT budget again next month.

## Site Council Minutes

The Abilene High School and Kennedy Elementary Site Council minutes were presented to the board.

Jennifer Waite moved to approve the Site Council minutes. Kyle Becker seconded the motion. Motion carried 7-0.

2018-2019 Kansas Association of School Boards (KASB) Membership Renewal/Legal Assistance Fees
The 2018-2019 KASB membership fee increased by \$48.37, making it \$11,070.37 and the legal
assistance fees increased by \$450, making it \$2,100. There was also an optional season pass for seminars which
would cost \$1500. Discussion was held.

Mark Wilson moved to renew the KASB membership without the season pass and to continue the Legal Assistance Service. Jennifer Waite seconded the motion. Motion carried 7-0.

## **Board-Administrator Communications**

#### Board-Administrator Communications

Administrator reports were available for board members to review. The district parent survey, staff MTSS system survey, and the state testing calendar were also available for the board to review.

#### Other

Dr. Guy reported on the school finance law that was passed noting that the base aid would increase to \$4900 per pupil next year, but that figure includes 15% of the LOB state aid. There would still be weightings.
