Learning Partnerships

City of Abilene Revitalization

James Holland was present to talk about the Abilene revitalization program. A new resolution was presented to the board to adopt which would include Garfield in the revitalization program.

Randy Gassman moved to adopt the changed revitalization program resolution. Gregg Noel seconded the motion. Motion carried, 6-0.

Student Development

Reclassification

Mr. Burton updated the board on the reclassification of schools for the different KSHSAA sports programs. This reclassification would not take affect until the 2018-19 school year. He noted that each sport's regular season would remain the same except for football which he explained in further detail.

Presentation

College & Career Competency Framework

Members of the high school staff presented the College & Career Competency Framework which has been implemented. The presentation included the history, brainstorming, introduction of the program, GRIT (goal setting, respect, integrity, tenacity), the college & career competency wheel, and examples of how GRIT worked in the classroom. The focus is on embedding skills within the classroom context. Since implementing, the total incidents of detention, in-school suspensions, and out-of-school suspensions went from 361 incidents in 2015-16 to 176 incidents in 2016-17.

Student Development

SOS: Suicide Prevention Curriculum

Dr. Guy informed the board that Abilene Cares and administrators are putting together a curriculum using the SOS: Suicide Prevention Program to educate people about suicide and the resources available. This is still in the planning stages.

Automotive Club

The board was given the second viewing of the Automotive Club's constitution and by-laws. Josh Peterson was present to answer questions. The club would meet during the day during seminar.
