After School Program

Chris Cooper updated the board on the history, budget, and evaluation of the After School Program, noting the increase in the number of participants along with the decrease in grant money. Dan Brown and Jenny Wilkins gave a brief overview of the current year's programs and activities.

Economic Development Vision for Garfield

Bob Morando from the Dickinson County Economic Development presented ideas on the use for Garfield emphasizing the need for collaboration.

Action/Discussion Item

Resolution for Board of Education Terms

Gregg Noel moved to approve the following resolution:

BE IT RESOLVED THAT, the Board of Education of Unified School District No. 435, Dickinson County, Kansas hereby extends the term of office for any elected board member whose term would expire at any time in 2017 until the second Monday in January of 2018, when newly elected members of the governing body and other newly elected officials shall take office pursuant to K.S.A. 2015 Supp. 25-21a01.

Kari Porter-Murray seconded the motion. The motion carried 5-0.

Community Foundation PE Heart Monitors Project

The Abilene Middle School received a grant from the Community Foundation for \$6,891 for the Physical Education Heart Monitors Projects. Middle School PE teacher, Diane Wyatt, explained to the board the purpose and usage of the heart monitors.

Jeff Bathurst moved to approve the grant. Gregg Noel seconded the motion. The motion carried 5-0.

BCBS Healthy Habits for Life Grants

Abilene Middle School and Eisenhower School each received a \$1000 Healthy Habits for Life grant from Blue Cross and Blue Shield of Kansas Foundation. Eisenhower School Principal, Ethan Gruen, and Middle School PE Teacher, Diane Wyatt, described how they will be using the grant funds.

Mark Wilson moved to accept the two grants. Jeff Bathurst seconded the motion. The motion carried 5-0.

Community Foundation Summer Science Grant

USD 435 received a \$5000 grant from the Community Foundation for the 2017 Summer Science Camp. Dr. Guy explained that this program would be a continuation from last year.

Gregg Noel moved to approve the \$5000 grant from the Community Foundation with thanks. Jeff Bathurst seconded the motion. The motion carried 5-0.

Facilities & Technology

Strategic Plan & Board Goals Adjustments

Dr. Guy updated the board on the adjustments made to the strategic plan and the board goals by the administration based on the board's input. The adjustments were as follows:

- PLS Expand the New Teacher training to 5 days to assure staff are trained on the required strategies and resources for success.
- SD1.2 FT3 Expand staff to include a K-12 Social Worker. Develop job description.
- SD LP2 (State requirement for accreditation) Implement Individual Plans of Study with all Middle and High School students. Meet with students and parents as these plans are being developed as well as when they are updated.
- LP1.2 CE Develop a system that tracks and teaches the importance of service learning in our community.

Discussion was held.

Gregg Noel moved to approve the draft goals based on the BOE retreat. Mark Wilson seconded the motion. The motion carried 5-0.

Capital Outlay

Dr. Guy updated the board on the e-rate funds that were approved. Mike Liby explained the types of items the district would be purchasing.

Community Engagement

A draft of the 2017-18 calendar was presented to the board. Discussion was held. The administration will make adjustments to the calendar based on the board's input.

Approval of Amended/New Policies

Dr. Guy recommend to insert the amount of \$100 in policy DFAB for the cost of accepting free product samples and meals. The Board agreed with the recommendation.

Approval of New Privately-Owned Vehicle (POV) Mileage Reimbursement Rate
