Bullying Prevention Month

With October being bullying prevention month, additional focus is given to the ongoing teaching opportunities in the district along with the working together of adults in the community to help prevent bullying. The Board reviewed the current policies.

District Learning Report

Mrs. Sprinkle presented the FastBridge assessments results which showed the students' skill levels in reading and math and compared it to previous years. This assessment showed that remote learning has a greater negative impact with younger students. Discussion was held.

COVID Considerations

The Gating criteria was presented along with options that would allow for face to face learning due to the challenges of remote learning. Discussion was held. It was noted that patrons wanted and needed kids at school. Mr. Brown emphasized that the school's job is to educate kids in a face to face setting. Mental health was also discussed.

Discussion was held concerning purchasing bus cameras which would allow for the identification of students and staff who came into contact with someone who tested positive for COVID. The estimated cost for the cameras would be around \$29,000.

Veronica Murray moved to approve outfitting the district buses with cameras and to give Mr. Brown the authority to do so. Randy Gassman seconded the motion. Motion carried 6-0.
